**Note: During the first 11 months of the 2022, the external net financing reached a positive value representing 634,34 mln. US dollars. Considering the negative fluctuation of the US dollar exchange rate against other currencies amounting to -171,16 mln. US dollars, the external central government debt outstanding as of November 30, 2022 has increased by 463,18 mln. US dollars or 18,48%, compared with the external central government debt outstanding as of January 01, 2022.**
